JUROR:

Brice McCasland is a visual artist and educator working out of McKinney, Texas. Brice earned his Bachelor of Science in K-12 art education with an emphasis in printmaking from Western Colorado University in Gunnison, CO. Brice has spent the last 17 years building the visual art program at Lovejoy ISD, where he is honored to serve as the K-12 Visual Art Coordinator, AP Studio Art Lead, and Gallery Manager. As a founder of LJVA, he has had the opportunity to help create a K-12 studio experience that is focused on practice, process, inquiry, and personal voice as a platform for student growth. During his time teaching AP Studio Art at Lovejoy, Brice's students have consistently been featured as exemplary for the College Board's AP Studio Art Portfolio. Brice's belief in visual arts' irreplaceable ability to narrate and navigate this life carries over to his professional career as a mixed media artist, showing his work in art festivals around the country. He was selected as the Featured Artist for the Des Moines and Cottonwood Art Festivals. He has served on the jury for both the DMAF and the Cherry Creek Art Festival where he currently serves on the artist advisory committee. Brice is a native of Lubbock, Texas.

\$30 per entry. • Each artist may have no more than three works represented in the show, but the number of entries is limited to 10. • Entry fees are non-refundable.

- Juried Gallery will be in the 1/3 Banquet Room of the Lubbock Memorial Civic Center.
- Artists must obtain a Texas Sales Tax number to apply to the Juried Exhibit. Artist is responsible for remitting all state and local sales tax and reports.
